Roll call was taken with the following council members present: Mike Ensminger, Ryan Horton, Lori Lundgren, Craig McCarty and Tana Pope. Mayor Biesemeier led the group in the Pledge of Allegiance.

Public Comment:

Jenn Oberle and Julie Thayer were invited to speak to the council regarding upcoming events that were planned for the summer of 2020. Jenn explained to the council that the Haxtun Chamber of Commerce would like to hold events, but that events will look different this year than in past years.

The council asked the question, what would happen if we just did the events? Unfortunately, it comes down to liability on the town and individual council members if a person would be injured or hurt or property damaged. Because we are a governmental entity, we must follow the orders handed down from the state.

The Chamber is looking at different ways to hold the car show later in August and possibly a cruise night in July instead of the traditional show. They will continue to be in touch with the council and are open for other ideas, such as a Farmers Market, Garage Sales, etc.

A motion was made by R. Horton and seconded by C. McCarty to appoint Bob Cionek as Trustee, to fill Brandon Biesemeier's place on the council. All present voted in agreement, and the motion carried.

The Oath of Office was given to Bob by Karie Wilson.

At this time, the swimming pool cannot be open per state regulations. Ron recommended to the council to close the pool for the season. Discussion was held about updating the basketball courts to make it easier for more children to access. Ron will look at the current courts to see what can be done.

A motion was made by C. McCarty and seconded by T. Pope to close the pool, motion carried.

Collyn Heinz will head the Town of Haxtun Summer Ball Camps. We are excited to be able to offer the kids some kind of recreation. We have also started the Summer Fun Camps, and Librarian Vickie Freemeyer will also offer a Summer Reading Camp through the library.

The application for a special event liquor license was tabled until a date may be found for the chamber to hold their event.

A motion was made by T. Pope and seconded by C. McCarty to adopt Resolution 2020-6 designating authorized officials to sign on bank accounts. Motion carried, and the resolution is as follows:

Staff Reports:

Ron Carpenter: Town Superintendent

- The trash truck is still in the shop for repairs. Unfortunately, the engine repairs ordered
 has been misplaced somewhere in Denver on a shipping dock. We will continue to
 use the City of Holyoke's truck until the needed repairs arrive.
- Ward Electric has bid on two electric rebuilds: Replace 5 poles, and a rebuild of the power that supplies the Wheatland Heights addition.
- The company that is interested in acquiring the generators is going to start the removal the first couple of weeks in July. Our attorney is working on a contract that will state their services and liability waiver. The town crew will have to disconnect all the electrical wiring for the project.
- Looking at the price of concrete stands for the bulk fuel tank to enable us to move the tank to the Town Quonset west of town.
- Have hired two seasonal employees and looking for a full-time maintenance employee.
- Paving the 100 block of Wilson Street and 100 Block of Raymond Street will begin in July.
- The crew has re-routed the trash route to cut down on turns the truck makes on the pavement.
- Long term street repairs were discussed. The current street bond will expire in 2025. At that time, the funds (\$72,000 per year) will still be available to continue to be budgeted for street repairs. Discussion was held regarding borrowing additional funds to re-do more streets at a time. The council would like to have a long-term street repair plan in place, as this is a topic that is brought up by the public quite often.

Tanya Mayhew, Chief of Police:

- The department received their sign in information from the state for the FEMA funds available for expenses occurred during the pandemic. The guidelines have changed some, with no funding available for employees' salaries, and the minimum limits have also changed. We will continue to see what reimbursement may be available for the Town.
- The police department and the fire department each have their own Salamander license.
- Tanya went over the Standard Operating Procedures regarding the Nuisance Ordinance.
- Tanya reminded the council that when the 2020 Budget was adopted, the council cut her budget on the premise that if funds were needed by the police department, the council will allow the transfer to cover those expenses.
- The department has 5 candidates interested in the opening, interviews were held by the Oral Board. Otero College is holding a spot for the Town if we have a good candidate. The cost of the school is \$12,500. Colorado Mountain College has an opening, but the school is considerably higher at \$15,000-17,000. This is paid by the Town with an agreement with the employee for a 4 year contract with the Town of Haxtun. Some scholarships are available to offset expenses.

Karie Wilson, Town Clerk/Treasurer

- Kelsey worked with Melinda Groshans and submitted a variance for the gymkanas.
 It was approved by the Northeast Health Department today.
- The Haxtun Library is open for curb side delivery. The summer reading program will be held on the sidewalk and can hold up to 25 participants at a time.
- The Haxtun Summer Fun Camps are held inside the community center. We are allowed 8 participants and 2 instructors at a time.
- The Town Hall reopened our lobby to the public on May 19, 2020. So far, it has been going well. We have the suggested restrictions in place., like offering hand sanitizer and social distancing signs.

Council Concerns:

Bob spoke in regard to the poor condition of the rail road crossing. Brandon will draft a letter and will send it to NKC Railnet. He would also like to see the Town look into hosting a web site.

Lori wondered if Maricks was going to empty the recycling containers. They are full all the time. Ron has asked them to put the Town on a schedule, but Maricks does not want to. Ron has also talked to the county, but they do not have the manpower at this time to take on more recycling.

A motion was made by M. Ensminger and seconded by R. Horton to adjourn. The meeting was adjourned at 8:41 pm subject to the call of the Mayor.
