February 6, 2023 REGULAR MEETING MINUTES

Mayor Ensminger opened the Public Hearing for the Haxtun Gun Club Special Event Liquor Permit at 7:00 pm at the Haxtun Community Center. The following citizens were present: Bob Cionek, Dave Green, Ryan Horton, Tana Pope, Ron Carpenter, Tom Bullard, Dean Anderson, Wayne Thompson, and Kelsey Harms.

A discussion was held on the map/event presented. After no further discussion, the hearing was closed at 7:01 pm.

The Haxtun Town Council met for their regularly scheduled meeting at 7:01 p.m. following the close of the Special Event Liquor Permit Hearing. The meeting was opened by Mayor Mike Ensminger at the Haxtun Community Center. Roll call was taken with the following council members present; Bob Cionek, Dave Green, Tana Pope, and Ryan Horton, Lori Lundgren was absent. Mayor Ensminger led the group in the Pledge of Allegiance.

Regular Business:

Dean Anderson was given his oath of office as Trustee. Dean will serve until the next election in 2024. Dean was welcomed to the Council table.

A motion was made by R. Horton and B. Cionek to approve the Special Event Liquor Permit application for the Haxtun Gun Club. All present voted in favor, and the motion passed.

Resolution 2023-3 Airport CDOT Grant. Ron applied for a grant from CDOT to help install a new lighting system at the airport. The resolution allows the Town to accept the grant and approves Ron Carpenter to sign the contract as the Project Director. Ron updated the Council this grant will be 90/10 split with a total project cost of \$65,000. A motion was made by D. Green and seconded by R. Horton to approve the Resolution. All voted in favor, and the motion passes.

Town of Haxtun RESOLUTION 2023-3

WHEREAS:

The General Assembly of the State of Colorado declared in Title 43 of the Colorado Revised Statutes, Article 10, 1991 in CRS §43-10-101 (the Act) "... that there exists a need to promote the safe operations and accessibility of general aviation in this state; that improvements to general aviation transportation facilities will promote diversified economic development across the state; and that accessibility to airport facilities for residents of this state is crucial in the event of a medical or other type of emergency..."

The Act created the Colorado Aeronautical Board ("the Board") to establish policy and procedures for distribution of monies in the Aviation Fund and created the Division of Aeronautics ("the Division") to carry out the directives of the Board, including technical and planning assistance to airports and the administration of the state aviation system grant program. SEE CRS §43-10-103 and C.R.S. §43-10-105 and CRS §43-10-108.5 of the Act.

Any eligible entity operating a public-accessible airport in the state may file an application for and be recipient of a grant to be used solely for aviation purposes. The Division is authorized to assist such airports as request assistance by means of a Resolution passed by the applicant's duly-authorized governing body, which understands that all funds shall be used exclusively for aviation purposes and that it will comply with all grant procedures, grant assurances and requirements as defined in the Division's Program and Procedures Manual, ("the Manual") and the Airport Sponsor Assurances for Colorado Discretionary Aviation Grant Funding ("Grant Assurances") attached hereto as Exhibit C.

NOW, THEREFORE, BE IT RESOLVED THAT:

The **Town of Haxtun**, as a duly authorized governing body of the grant applicant, hereby formally requests assistance from the Colorado Aeronautical Board and the Division of Aeronautics in the form of a state aviation system grant. The **Town of Haxtun** states that such grant shall be used solely for aviation purposes, as determined by the State, and as generally described in the Application.

By signing this Grant Agreement, the applicant commits to keep open and accessible for public use all grant funded facilities, improvements and services for their useful life, as determined by the Division and stated in the Grant Agreement and Grant Assurances.

FURTHER BE IT RESOLVED:

That the **Town of Haxtun** hereby designates **Ron Carpenter** as the Project Director, as described in the Manual and authorizes the Project Director to act in all matters relating to the work project proposed in the Application in its behalf, including executions of the Grant Agreement and any amendments.

FURTHER:

The **Town of Haxtun** has appropriated or will otherwise make available in a timely manner all funds, if any, that are required to be provided by the Applicant under the terms and conditions of the Grant Agreement.

FINALLY:

The **Town of Haxtun** hereby accepts all guidelines, procedures, standards, and requirements described in the Manual as applicable to the performance of the grant work and hereby approves the Grant Agreement submitted by the State, including all terms and conditions contained therein.

Ron presented a contract from Maguire Iron with two different options for water tower repairs. Option 1 includes making minor repairs to the interior, pressure washing and cleaning all the rusted areas, and reapplying the epoxy finish. They will also replace the old rigid rail/ladder system for \$30,000.00. Option 2 includes all the repairs to the interior as well as the additional \$56,800.00 to completely wash, clean and repaint the exterior of the water tower.

Ron informed the Council that he did account for the \$30,000 in the approved 2023 budget. Maguire Iron did agree if the Council voted to do both the interior and the exterior project, they would only charge 1 mobilization fee and would defer the \$56,800.00 to February of 2024 to help with the budget. Ron noted that the exterior would need to be repainted at some point, the primer is showing, and the next layer is steel. If the steel is exposed for too long, rust will become an issue.

After some discussion about the work needed to the water tower and the history of repairs to the water tower, a motion was made by D. Green and seconded by R. Horton to approve option 2 of completing the whole project of \$86,800.00 paying \$30,000 in 2023 and the remaining \$56,800 in 2024. All present voted in favor and the motion passed.

A motion was made by T. Pope and seconded by D. Green to sign the Engagement Letter with Lauer Szabo & Associates for the 2022 financial audit.

Colorado Association of Municipalities (CAMU) requires members to designate a representative and an alternate who act on behalf of each member for activities of the Association. A motion was made by T. Pope and seconded by R. Horton to designate Ron Carpenter as the CAMU representative and Mike Ensminger as the alternate. All that were present voted in favor and the motion passes.

Since October of 2022, Tom Bullard has been serving as the Interim Police Chief. After some discussion during a previous work session, the Council has decided to offer Tom Bullard the position permanently with the following conditions: starting level Police Chief Salary, a 6-month probationary period that follows the Police policy already in place, and will allow Tom to roll the 4 additional vacation days from 2022 forward to the 2023 year. A motion was made by D. Green and seconded by T. Pope to appoint Tom Bullard as Haxtun Police Chief with the conditions set. All present voted in favor, and the motion passed. Tom was then given his oath of office and congratulated by the Town Council.

Resolution 2023-4 authorizing signatures on banking documents. This resolution changes the signers on the bank accounts for the newly appointed mayor, mayor pro tem, and the Police Chief. A motion was made by T. Pope and seconded by B. Cionek to approve the resolution, motion passed.

In January it was identified that the Haxtun Old Hire Police Pension Plan no longer has any participating members or beneficiaries. In order for the Town to close the account and distribute the funds, there are procedures that must be followed set by Colorado Statutes. Because this process will take several months, the Council can vote to move the Plan assets out of the short-term pool into a cash account. After some discussion, a motion was made by B. Cionek and seconded by R. Horton to move the assets to the cash account. All voted in favor and the motion passed.

A liquor license application for El Paso Mexican Restaurant was received. A public hearing for the hotel/restaurant liquor license will be held Tuesday, February 21, 2023 at 7:00 pm at the Haxtun Town Hall.

Discussion Items:

Ordinance 2021-4 section 06.06.07 Keeping of backyard chicken hens. Kelsey has had some inquiries about the keeping of chickens. In 2020 HB20-1343 was passed in Colorado Egg-laying Hen Confinement Standards and by 2025 all egg-laying hens in Colorado will be required to be cage-fee. Also due the avian flu egg prices are on the raise. In the current ordinance, it states facilities shall be at least 10 feet from any other structure and 10 feet from any side or rear property line. Kelsey and Ron had some discussion after citizen questions, and if a resident owns a smaller lot with these restrictions, it would not be possible for these residents. It was suggested to the Council to make this fit more like the current zoning ordinance which would allow chicken facilities to be at least 5 feet from side property lines and 1 foot from the rear property line. The Council felt that this was a good compromise. A new ordinance will be drafted for the March meeting.
