### **Public Comment:**

Jess Smith from Julesburg spoke to the Council representing Northeast Colorado Junk Jaunt. He is hoping to start a 3-day "junk jaunt" that would start in Julesburg and continue to Sterling, Holyoke, and end back in Julesburg catching all the Towns in between. Mr. Smith is hoping to have each Town Councils support to showcase NE Colorado and boost the local economy. He has two other members of his committee Jessica Ayala (Haxtun-Holyoke Chamber Director) and Linda LeAngelo. Jess will continue to update the Council as more details are confirmed.

### **Regular Business:**

A motion was made by D. Green and seconded by R. Horton to post public meeting notices on the front door of Town Hall, 145 S. Colorado Ave. All present voted in favor, motion passes.

Since the Town has voted to move forward with the application process to apply to become an official Colorado Main Street Community, a committee has been formed with the Main Street Manager Darcy Garretson. T. Pope is interested in the project and has volunteered to join the committee. A motion was made by D. Green and seconded by L. Lundgren to appoint T. Pope to the Main Street Committee. All present voted in favor, motion carried.

Colorado Highland Wind sent the Town a \$1,000.00 donation to use as the Council sees fit to best support the community. After some discussion about previous donations, a motion was made by D. Green and seconded by R. Horton to give half of the donation to Little Sprouts Learning Center and half of the donation to the local Food Basket. All present voted in favor, motion carried.

After D. Anderson's letter of resignation from the Town Council at the special meeting in December, the council was left with a vacant seat. The Council received a letter of interest from Jon Brammer when Anderson was appointed, Brammer expressed he was still interested in the position. The seat will be up for election in the November 2024 election. A motion was made by R. Horton and seconded by T. Pope to appoint Jon Brammer to fill the vacant Council seat. All present voted in favor, motion carried. Brammer will receive his official oath of office at the regular February meeting.

Resolution 2024-1 accepting the donation and conveyance of real property located at 205 S. Colorado Avenue. This resolution will allow the Council to formally accept the property donation as a general asset of the Town, not being donated or accepted for park or governmental purposes unless done so by subsequent ordinance or resolution. A motion was made to

approve Resolution 2024-1 by L. Lundgren and seconded by T. Pope. All present voted in favor, motion passed.

### Town of Haxtun RESOLUTION NO. 2024-1

# A RESOLUTION ACCEPTING THE DONATION AND CONVEYANCE OF REAL PROPERTY LOCATED AT 205 SOUTH COLORADO AVENUE

WHEREAS, the following described real property (the "Property") is owned by Gene-Jean Corporation, a dissolved corporation, and Vanda Jean Black, its last acting Director, along with all appurtenances and improvements on said Property:

Lots 1 and 2, Block 11, Original Town of Haxtun, Colorado EXCEPT the South 6 inches of said Lot 2 as heretofore conveyed to J.D. Birrell for party wall purposes, with reservations and rights therein as under deed recorded in Book 133, at Page 421 of the Phillips County records, Address of Property: 205 South Colorado Avenue, Haxtun, CO 80731; and

WHEREAS, the current owner of Property, has proposed donating the Property to the Town of Haxtun; and

WHEREAS, the Board of Trustees finds that such proposed donation is beneficial to the Town; and

WHEREAS, the Board of Trustees desires to accept such donation and hold the Property as a general asset of the Town, and not for park or governmental purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF HAXTUN, COLORADO:

Section 1. Ownership in fee simple of the above-described Property is hereby approved and accepted by the Town of Haxtun.

<u>Section 2.</u> Such ownership shall be evidenced by the Town's acceptance and recording of a warranty deed conveying the Property from Gene-Jean Corporation, to the Town. The acceptance of such donation is upon condition that, upon such acceptance, fee title to the Property shall be marketable and insurable in the name of the Town. The Board of Trustees hereby approves the attached form of deed for donation and conveyance of the Property.

<u>Section 3</u>. The Town takes title to the Property as a general asset of the Town. The Property is not being donated or accepted for park or governmental purposes, and shall not be held or used for such purposes unless and until the Board of Trustees by subsequent ordinance or resolution identifies and dedicates all or a portion of the Property to be used or held for park or governmental purposes of the Town.

Section 4. The Mayor and Town Staff are authorized to execute all documents and to do all things necessary on behalf of the Town to effect the Town's ownership of the Property.
